Correction to U.S. Chamber PDF on SBA Emergency Loans



In yesterday's news update, we included information on the Small Business Administration's two major loan programs in response to COVID-19 and linked to a <u>PDF guide to these programs</u>. The information contained there was correct except for the final bullet point under the first loan program, the Emergency Injury Disaster Loan (EIDL), which stated that EIDL assistance is available only to small businesses when SBA determines they are unable to obtain credit elsewhere. That was the case before CARES Act was passed last week, and removed that requirement. That means that EIDL is available to many credit-worthy businesses that may have been ineligible before. Reach out to the SBA to find out if your business is eligible.
